- Parking and beverages are not included in all packages. Parking passes and open bar options may be added with advance payment.
- All bar packages and bar service conclude at post time of the final race of the day.
- In all dining areas, NYRA's contracted caterer is the single provider of all menu items and beverages. No food or beverages are to be brought onto or removed from our premises by the patron or their guests without permission of NYRA.
- A non-refundable deposit of \$350.00 is required to reserve the date.
- Menu selections and final guarantee must be made 14 days prior to event date.
- No decreases in guarantee count will be accepted any later than 72 hours prior to event date.
- Full payment due two (2) weeks prior to the event by credit card or check made payable to THE NEW YORK RACING ASSOCIATION INC.
- In the event that races are canceled due to weather conditions, strike or other circumstances beyond NYRA's control, we shall be under no obligation or liability beyond the return of any sums received by NYRA. (NYRA will make every effort to reschedule the group event.)
