## GENERAL INFORMATION

The 2010 Belmont Park Meet begins on Friday, April 30<sup>th</sup> and concludes on Sunday, July 18<sup>th</sup>. There is live racing every day except Monday's and Tuesday's. The gates open daily at 11:00 A.M. with the first race post time of 1:00 PM with the exception of Sunset Friday's when the first race starts at 2:30 P.M. The last live race generally concludes at approximately 5:30 P.M. Access to all dining areas begins at 11:30 A.M. Guests have access to their assigned tables until the last live race is official.

Clubhouse admission, the Post Parade Programs, tax and gratuities are included in all Group Sales Dining Packages. Beverages are additional and can be paid for with cash or credit card, directly to the caterer, at the close of the event date. All bar packages and service conclude at post time of the final live race.

Programs will be handed out at the turnstiles in the Clubhouse Entrance or your ticket can be shown at any program selling location. **If patrons do not collect their program on the way in, it is their responsibility to go back and get one.**

### *Ticket Process*

*Once we have received the signed agreement form, with your 20% down payment we will process the paperwork. You will receive an invoice with your tickets. Each of your guests should get a three part perforated ticket which includes, admission, program and lunch. **Do not rip apart;** the Admissions clerk will do that for you.*

**◆ TERMS OF AGREEMENT ◆**

- All Group packages include lunch, admission, the Race Program, tax and gratuities. (Tax exempt pricing applied with a copy of a current and valid NY State tax exempt certificate submitted with deposit.)
- All rights not specifically granted herein are reserved by NYRA.
- The Group agrees that it shall not tape and/or exhibit any film or video on the Premises without the express written consent of NYRA.
- Special seating requests will be considered by the maitre d' but will be subject to availability.
- Parking and beverages are not included in all packages. Parking passes and open bar options may be added with advance payment.
- All bar packages and bar service conclude at post time of the final race of the day.
- In all dining areas, NYRA's contracted caterer is the single provider of all menu items and beverages. No food or beverages are to be brought onto or removed from our premises by the Group or its guests without permission of NYRA.
- **A non-refundable deposit of 20% of the total booking amount is required to reserve the date *\*and the attached Credit Card Authorization form must be completed by Group in order to guarantee any booking hereunder.***
- **Menu selections and final guarantee must be made 14 days prior to event date.**
- **No decreases in guarantee count will be accepted any later than 72 hours prior to event date.**
- **Full payment due 21 days prior to the Event by credit card or check made payable to THE NEW YORK RACING ASSOCIATION, INC. *Payments by check for Events over Five Thousand Dollars (\$5,000.00) must be made by cashier's check. Personal checks for Events over \$5,000.00 will not be accepted. Group hereby agrees that any and all unpaid fees and/or expenses arising under this Agreement shall be charged to the credit card provided on the attached Credit Card Authorization form (including, but not limited, to bar tabs, etc. established by the Group during the Event)***
- In the event that races are canceled due to weather conditions, strike or other circumstances beyond NYRA's control, NYRA shall be under no obligation nor have any liability to the Group beyond the return of any (refundable) payments received by NYRA from the Group; provided, however, that NYRA is unable to reschedule the Group Event.
- Group agrees to indemnify and defend NYRA and its directors, officers, employees, agents, contractors, and servants against, and to hold all of them harmless from and against, any liability, judgment, costs, suits, claims, or expenses (including attorneys' fees), losses, injuries, or damages caused by Group, or which result as a consequence of a breach of this Agreement by Group, or any condition created, caused, or permitted by Group, its agents, servants, employees, or invitees. Group agrees to use its best efforts to prevent damage to the Premises and property, and will indemnify, reimburse and make NYRA whole, and all other parties lawfully upon or in possession of said Premises or property, for injuries to persons or animals, death, or property damage suffered or incurred as a result of Group's operations or as a result of Group's breach of this Agreement.
