SHIPPING AND HANDLING:

A fee of \$10.00 will be applied to each group ticket order. Please include this fee with full payment. Once full payment is received, a two-part Group Sales Ticket will be provided for each of the contracted number of guests. The first part of the ticket will provide Clubhouse Entrance and the second part will be for admission to the Dining Location.

DRESS CODE:

It is the responsibility of the Group coordinator to inform all guests of the dress code required in The Clubhouse. Business casual is recommended and although jackets are not required they remain an option. Bermuda shorts are permissible in the Carousel but, not in the Clubhouse. No shorts or other abbreviated wear will be permitted in the Winners' Circle.

CANCELLATION:

There are no cancellations, refunds or exchanges on the final guaranteed number of attendees. In the event the races are cancelled, NYRA shall make every effort to reschedule the Group's Event. NYRA reserves the right to relocate the Event if necessary.

SARATOGA RACE COURSE GROUP DINING PACKAGES

PLAN "A" – THE AT THE RAIL BUFFET – Weekdays/Sundays: \$65.00 pp. (20 or more), \$75.00 (less than 20) - Saturdays: \$70.00 pp. (20 or more), \$80.00 (less than 20) – Travers Day \$90.00 (20 or more), \$100.00 (less than 20).

Situated in the Clubhouse, the At the Rail Pavilion offers a trackside view of all the live racing action. Included in the price is clubhouse admission, an elaborate buffet, bar service and conveniently located betting facilities and restrooms. The menu typically includes an omelet station, a pasta station, a carving station, a variety of hot entrees, assorted salads, cakes and a sundae bar. Dress code is Business Casual, **No** jeans, shorts or other abbreviated wear.

Gentlemen: Collared Shirts required but, sports jackets are optional.

Ladies: Dresses, Skirts or Pant Suits.

PLAN "B" – THE Carousel BUFFET – Weekdays/Sundays: \$35.00 pp. (20 or more), - Saturdays: \$40.00 pp (20 or more). Travers' Day: \$50.00 pp. (20 or more).

The Carousel is located on the second floor of the Clubhouse and overlooks the picturesque picnic area of Saratoga Racecourse. The hot and cold buffet changes daily and generally includes a carved meat selection, chicken, vegetables, pasta, cold meats, salads and a variety of desserts. One is given Clubhouse access with this package and Grandstand Reserved Seating can be purchased at a price of \$6.00 per seat (subject to availability---Not available Travers' Day). The Carousel is equipped with televisions and betting windows. Dress code is Neat Casual and although Bermuda shorts are permitted in the Carousel, they are not acceptable in the Clubhouse areas or the Winners' Circle.

PLAN "C" – Carousel TRACK PACK - \$45.00 pp. – Travers' Day: \$55.00 pp.

For groups of nineteen or less, we offer the Track Pack. This package provides Clubhouse Admission, the Post Parade Program, access to the Carousel Tent Buffet, tax and gratuity. Full payment is required with Track Pack orders.

PLAN "D1-2" – THE CAROUSEL BUFFET - Weekdays: \$55.00 pp. – Weekends: \$60.00 pp. – Not available Travers' Day Saturday, August 28, 2010.

The Carousel is located on the second floor of the Clubhouse and overlooks the picturesque picnic area of Saratoga Racecourse. The cold buffet features sliced beef tenderloin, chilled roasted turkey, spiral ham, assorted cold salads, vegetables and desserts. The Carousel is equipped with televisions and betting windows. The Grandstand Reserved Seats are just steps away and can be purchased for \$6.00 weekdays or \$7.00 weekends (subject to availability---Not available **Travers' Day Saturday, August 28, 2010**). Clubhouse dress code: Business casual, **No** jeans, shorts or other abbreviated wear, collared shirts for gentlemen.

GENERAL INFORMATION

The 2010 Saratoga Race Meeting begins on Friday, July 23rd and concludes on Monday, September 6th. There is live racing every day except Tuesday. The gates open at 11:00 A.M. on weekdays, 10:30 A.M. on weekends with the first race post time of 1:00 PM with the exception of Sunset Friday's July 30th and September 3rd when the first race starts at 2:45. On Travers Day, Saturday, August 28th, the gates open at 7:00A.M. and the first race is scheduled for 12:30 P.M.

The last live race generally concludes at approximately 5:30 P.M. and simulcast races end at approximately 7:00 P.M.

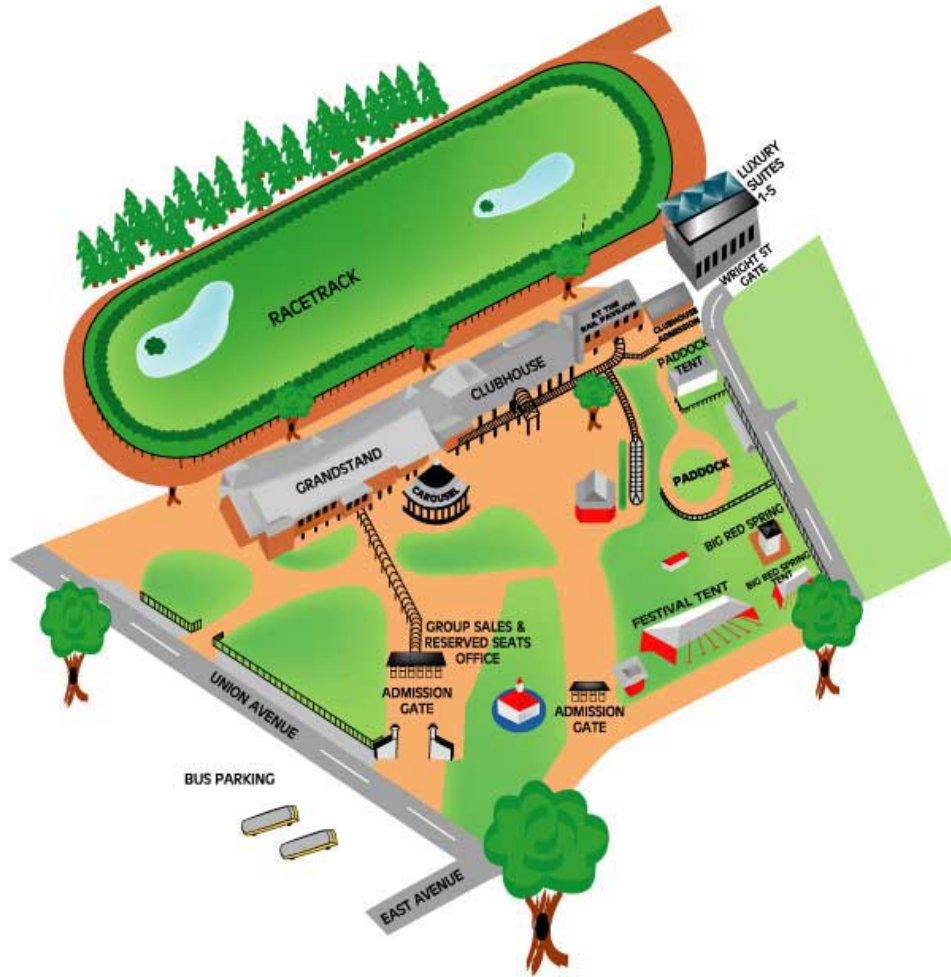
Access to all dining areas begins at 11:30 A.M. with the exception of Travers' Day when one can arrive at 11:00 A.M. The buffets generally open at 12:00 P.M. and continue until 3:00 P.M. Guests have access to their assigned tables until the last live race is official.

Clubhouse admission, the Post Parade Programs, tax and gratuities are included in all Group Sales Dining Packages. Beverages are additional and can be paid for with cash or credit card. All bar packages and service conclude at post time of the final live race.

Patrons must collect their own program by showing your ticket at any program selling location. **If patrons do not collect their program on the way in, it is their responsibility to go back and get one.**

General parking is free of charge. Buses are offered complimentary parking in the Oklahoma Bus Parking Area, located just inside East Avenue.

◆ TERMS OF AGREEMENT ◆

- All Group packages include admission, the Race Program, tax and gratuities. **(Tax exempt pricing applied with a copy of a current and valid NY State tax exempt certificate submitted with deposit.)**
- All rights not specifically granted herein are reserved by NYRA.
- The Group agrees that it shall not tape and/or exhibit any film or video on the Premises without the express written consent of NYRA.
- Special seating requests will be considered by the maitre d' but will be subject to availability.
- Parking and beverages are not included in all packages. Parking passes and open bar options may be added with advance payment.
- All bar packages and bar service conclude at post time of the final race of the day.
- In all dining areas, NYRA's contracted caterer is the single provider of all menu items and beverages. No food or beverages are to be brought onto or removed from our premises by the Group or its guests without permission of NYRA.
- **A non-refundable deposit of 20% of the total booking amount is required to reserve the date *and the attached Credit Card Authorization form must be completed by Group in order to guarantee any booking hereunder.***
- Fifty percent (50%) of the remaining balance is due by **March 1, 2010**. FULL PAYMENT and FINAL guaranteed number of attendees is required by **May 1, 2010**. **There are no cancellations, refunds or exchanges on the final guaranteed number of attendees.** Payments by check are to be made payable to THE NEW YORK RACING ASSOCIATION, INC. **Payments by check for Events over Five Thousand Dollars (\$5,000.00) must be made by cashier's check. Personal checks for Events over \$5,000.00 will not be accepted.** *Group hereby agrees that any and all unpaid fees and/or expenses arising under this Agreement shall be charged to the credit card provided on the attached Credit Card Authorization form (including, but not limited, to bar tabs, etc. established by the Group during the Event).*
- In the event that races are canceled due to weather conditions, strike or other circumstances beyond NYRA's control, NYRA shall be under no obligation nor have any liability to the Group beyond the return of any (refundable) payments received by NYRA from the Group; provided, however, that NYRA is unable to reschedule the Group Event.
- Group agrees to indemnify and defend NYRA and its directors, officers, employees, agents, contractors, and servants against, and to hold all of them harmless from and against, any liability, judgment, costs, suits, claims, or expenses (including attorneys' fees), losses, injuries, or damages caused by Group, or which result as a consequence of a breach of this Agreement by Group, or any condition created, caused, or permitted by Group, its agents, servants, employees, or invitees. Group agrees to use its best efforts to prevent damage to the Premises and property, and will indemnify, reimburse and make NYRA whole, and all other parties lawfully upon or in possession of said Premises or property, for injuries to persons or animals, death, or property damage suffered or incurred as a result of Group's operations or as a result of Group's breach of this Agreement.
